**05. SELECTION PROCEDURE:** - Candidates whose applications are found in order will be put through the following selection procedure.

<b>a) Trail /Test in sports events:-</b>	Those who fulfill the eligibility criteria will be put through the test in the sports event to which he/she belongs. This organization will not be responsible for any accident/injury caused to the candidate during the course of trail/test.
<b>b) Final Selection:-</b>	Final Selection of candidates will be made strictly according to merit taking into consideration the performance of the candidates during the course of trail/test though the achievement/performance of the candidates during the last two years will also be taken into consideration.
<b>c) Medical Examination:-</b>	The finally selected candidates will be got medically examined and their appointment in the CISF would be subject to their fitness in the medical examination.
