Vertical Reservation to Differently Abled Candidates will be allowed as per Rules.

#### A. Educational Qualification:

- i. Essential Qualification:
  - (a) MBBS degree with one year of internship from recognized university/ institute
    - (b) A postgraduate Medical Degree/Diploma/DNB in respective discipline from MCI recognized university/ Institute.
- ii. Candidates must be Registered with Delhi Medical Council
- iii. Upper age limit: 40 years as on 31/05/2015. This is relaxable for SC/ST candidate up to a maximum period of five years, for OBC candidates up to a maximum period of three years. In case of Differently Abled, age relaxation up to a maximum period of 5 years for General Category, 8 years for OBC category and 10 years for SC/ST category candidates.
- iv. Reservation: Reservation for SC/ST/OBC/OPH shall be applicable as per Govt. of India policy.
- v. Pay: Pay Band-3 with Grade Pay of Rs.6600/- plus NPA plus usual allowances.

#### B. Application procedure:

- i. The application form for the above positions can be downloaded from Delhi Govt. website. <a href="www.delhi.gov.in">www.delhi.gov.in</a> -> enter vacancy -> Health & Family welfare Department) or can be obtained from the Admn. Branch. The duly filled application form along with the self- attested photocopies of all relevant certificates relating to age, qualifications and category with one recent passport size photograph and the requisite application fee (Rs.300/-) should be submitted with the administrative block, L.B.S. Hospital on or before 11/06/2015 3:30 P.M
- ii. Medical Superintendent, L.B.S.H. reserves the right to cancel the advertisement at any point of time without prior notice or increase/ decrease the number of posts as advertised depending upon the institutional requirement.
- iii. Candidates should bring :-

The original certificates i.e. MBBS Degree Certificate, Internship completion certificate, P.G. Degree/Diploma/Others, Medical Registration Certificate, Date of Birth Certificate, Caste Certificate etc., at the time of Submission of form and also at the time of interview.

If any candidate who joins the post and wants to leave/resign before the completion of the tenure, he/she may do so by giving one month notice or by depositing pay and allowances with the Institute for the period for which notice falls short of one month.

#### C. Selection procedure:

- i. Interview.
- ii. After filling available posts, candidates called for interview shall be kept in the waiting list.
- iii. Any vacancy arising because of non joining by selected candidates in this selection or by resignation of candidates post will be offered to the candidates from the waiting list according to the merit. All applicants must provide phone (local) numbers and email/ for faster communication about such vacancies.
- iv. Separate lists will be prepared for fresh and other candidates.
- v. Experience/Age/etc. will be counted as on 31/05/2015.

#### D. Terms and Conditions:

- i. Pay Structure: Pay Band 3 (Rs.15600-39100)+Gr.Pay of Rs.6600+NPA+DA+usual allowances.
- ii. Services of S/R will be governed by Residency Scheme and their appointment will be for a period of 03 years (Initially for one year extendable for three years subject satisfactory work & conduct) from the date of appointment.
- iv. Their engagement is liable to be terminated in case of misconduct or if their antecedents are reported to be unsatisfactory at any stage or for mis-representation of material facts.
- v. Also their appointment can be terminated at any time with one month notice by either side.
