Mumbai Port Trust (MbPT) invites applications for recruitment in Class I (15 posts), Class II (1 post) and Class III (7 posts) by direct recruitment.

Prospective candidates will have to apply online after carefully reading the advertisement regarding the process of examination, interview, eligibility criteria, online registration processes, payment of prescribed application fee/intimation charges, pattern of examination, issuance of admit cards/call letters etc. and ensure that they fulfil the stipulated criteria and follow the prescribed processes.

Note 1: The discipline wise number of posts mentioned above are provisional/indicative. The Port reserves the right not to select any candidate from any of the disciplines mentioned above. The discipline wise numbers indicated above may vary and /or can be interchanged at any stage of recruitment process. The reservation under various categories will be as per prevailing Government Guidelines at the time of finalization of result.

- **Note 2:** Candidates can apply for more than one post subject to their fulfilling eligibility criteria. However, separate applications are required to be submitted for each post applied for, with separate fees/charges.
- **Note 3:** Not more than one application should be submitted by any candidate for one discipline. In case of multiple Applications only the latest valid (completed) application will be retained and the application fee/Intimation charges paid for the other multiple registration(s) will stand forfeited.
- **Note 4:** Most of the jobs may demand outdoor work requiring considerable physical efforts & technical skills.

II. Emoluments & Benefits

a) For CLASS I posts:

Basic pay of Rs.20600/- in the scale of Rs.20600-46500 and other admissible allowances as applicable. Total emoluments will be approximately Rs.52000/- per month plus HRA @ 30% of Basic Pay (if not residing in Mumbai Port Trust quarters)

b) For CLASS II posts:

Basic pay of Rs.16400/- in the scale of Rs.16400-40500 and other admissible allowances as applicable. Total emoluments will be approximately Rs.41000/- per month plus HRA @ 30% of Basic Pay (if not residing in Mumbai Port Trust quarters)

(c) For Class III posts:

- (i) For Jr Engineer Gr III (T/E, Mech, Elect) Basic pay of Rs.19100/- in the scale of Rs.19100-51100 and other admissible allowances as applicable. Total emoluments will be approximately Rs.26000/- per month plus HRA @ 30% of Basic Pay (if not residing in Mumbai Port Trust quarters).
- (ii) For Jr Engineer Gr IV Basic pay of Rs.17700/- in the scale of Rs.17700-44600 and other admissible allowances as applicable. Total emoluments will be approximately Rs.24200/- per month plus HRA @ 30% of Basic Pay (if not residing in Mumbai Port Trust quarters).

III. ELIGIBILITY CRITERIA

Candidates, intending to apply for the above posts should ensure that they fulfill the minimum eligibility criteria specified hereunder:

1. Nationality

A candidate applying for recruitment in the Mumbai Port Trust must be either-

(a) a citizen of India, or (b) a subject of Nepal, or (c) a subject of Bhutan, or (d) a Tibetan refugee who came over to India before 1st January, 1962 with the intention of permanently settling in India, or (e) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania, Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India.

Provided that a candidate belonging to categories (b), (c), (d) and (e) shall be a person in whose favour a certificate of eligibility has been issued by the Government of India.

2. Minimum/Maximum Age [To be reckoned as on 1.2.2016]

i) For Class I posts: Upper Age limit: not more than 30 years

Candidate must have been born not earlier than 2.2.1986 and not later than 1.2.1998 (both days inclusive).

ii) For Class II post: Minimum Age: 23 years Maximum Age: 30 years

Candidate must have been born not earlier than 2.2.1986 and not later than 1.2.1993 (both days inclusive).

iii) For Class III posts:

(a) Jr.Engineer Gr III (T/E) - Minimum Age: 18 years Maximum Age: 30 years.

Candidate must have been born not earlier than 2.2.1986 and not later than 1.2.1998(both days inclusive)

(b) Jr.Engineer Gr III (Mech) - Minimum Age: 18 years **Maximum Age:** 30 years.

Candidate must have been born not earlier than 2.2.1986 and not later than 1.2.1998 (both days inclusive).

(c) <u>Jr.Engineer Gr III (Elect)</u> - Minimum Age: 18 years Maximum Age: 30 years.

Candidate must have been born not earlier than 2.2.1986 and not later than 1.2.1998 (both days inclusive).

(d) <u>Jr.Engineer Gr IV</u> - Minimum Age: 21 years Maximum Age: 30 years.

Candidate must have been born not earlier than 2.2.1986 and not later than 1.2.1995 (both days inclusive).

iv) Relaxation in upper age limit shall be as follows (for all posts):

Note:

- i. Candidates seeking age relaxation will be required to submit copies of necessary certificate(s) and produce the original certificate(s) for verification at the time of interview and /or at the time of any stage of recruitment process as may be required by MbPT.
- ii. If any SC, ST, OBC or PWD category candidate applies for a post under UR, then he is not eligible for relaxation in age.
- iii. As per Regulation 9 of MbPT Employees' (RSP) Regulations, 2010, there is no age limit in case of existing Mumbai Port Trust Employees.

Note 1: Candidates applying for the Class III posts should be registered with local Employment Exchange [in terms of Regulation 10(1) of the Mumbai Port Trust Employees' (Recruitment, Seniority and Promotion) Regulations, 2010]. The candidates registered with the local Employment Exchange have to apply online and mention their registration number in the field provided for the same in the Application Form.

Note 2: Qualifications mentioned above should be from any of the recognized Indian Universities duly approved by the UGC or any of the recognized Indian Institutes duly approved by AICTE.

The candidate must possess valid Mark-sheet / Degree/Diploma / Certificate of the necessary qualification and Experience as on 1.2.2016.

Note 3: Candidates must possess the essential qualifications mentioned against each post, i.e., for example where essential qualification is Diploma, candidates not possessing Diploma will not be eligible.

Note 4: While no posts are reserved for Persons with Disability (PWD), only OH (Orthopedically Handicapped) category (with impairment of minimum 40%), can apply for the posts of Class I as these posts are identified for OH category. However, PWD candidates can not apply for the posts in the Class II and Class III categories, as these posts are not identified for PWD candidates.

Guidelines for Persons with Disabilities using a Scribe

Those candidates who are affected by cerebral palsy with loco-motor impairment and whose writing speed is affected can use own scribe at own cost during the online examination. In all such cases where a scribe is used, the following rules will apply:

- The candidate will have to arrange his / her own scribe at his/her own cost.
- The scribe may be from any academic stream.(for generalist discipline)
- The scribe should be from an academic stream different from that stipulated for the post (for specialist discipline).
- Both the candidate as well as scribe will have to give a suitable undertaking confirming that the scribe fulfils all the stipulated eligibility criteria for a scribe mentioned above. Further in case it later transpires that he/she did not fulfill any laid down eligibility criteria or suppressed material facts, the candidature of the applicant will stand cancelled, irrespective of the result of the examination.
- Those candidates who use a scribe shall be eligible for compensatory time of 20 minutes for every hour of the examination.
- The same scribe cannot be used by more than one candidate. In addition, the scribe arranged by the candidate should not be a candidate for the examination. If violation of the above is detected at any stage of the process, candidature of both the candidate and the scribe will be cancelled. Candidates eligible for and who wish to use the services of a scribe in the examination should invariably carefully indicate the same in the Application Form. Any subsequent request may not be favorably entertained.

For PWD (OH) candidates (With Locomotor disability and cerebral palsy), an extra time of twenty minutes per hour shall be permitted for the candidates with Locomotor disability and cerebral palsy where dominant (writing) extremity is affected to the extent of slowing the performance of function (minimum of 40% impairment).

Note 5: Please note that the eligibility criteria specified herein are the basic criteria for applying for the post. Candidates must necessarily produce the relevant documents pertaining to category, nationality, age, educational qualifications etc. in original along with a photocopy thereof in support of their identity and eligibility as indicated in the online application form. Please note that no change of category will be permitted at any stage after registration of the online application and the result will be processed considering the category which has been indicated in the online application, subject to guidelines of the Government of India in this regard. Merely applying for online examination/ appearing for and being shortlisted in the online examination and/or in the subsequent interview and/ subsequent processes does not imply that a candidate will necessarily be offered employment in MbPT. No request for considering the candidature under any category other than in which applied will be entertained.

Note 2: Mumbai Port Trust reserves the right to modify the structure of the online test.

V. Cut off Score:

Each candidate will be required to obtain a minimum score of 35% marks in each section of the online test separately for being considered for short listing.

Note1: Mumbai Port Trust reserves the right to alter the minimum score required in each section for being considered for shortlisting, if required.

Note 2: Mumbai Port Trust reserves the right to restrict the number of candidates for shortlisting/interview as applicable.

VI. Selection Procedure:

For Class I & II posts, the candidates have to appear for an online test as mentioned in Para IV of the advertisement. The shortlisted candidates from online test may be called for interview. The selection will be made on the basis of overall performance in Online Examination and Interview.

In respect of post of Asstt. Security Officer, shortlisted candidates based on online test will have to undergo Physical requirement tests and test of proficiency in essential language. The candidates complying with the necessary physical standards and passing language proficiency test (35% minimum in each language separately) will only be eligible for further participation in recruitment process.

For Class III posts, selection will be made on the basis of performance in Online Examination.

The selection of shortlisted candidates for all posts will be subject to verification of required documents as indicated in this advertisement, in original. Non submission of requisite documents by the candidate during this process will disqualify his candidature from further participation in the

recruitment process. Further, in case it is found during verification that requisite documents do not meet the prescribed criteria, his candidature will not be considered any further in the recruitment process.

VII. Intimation Charges/Application Fee (Non-Refundable):

Candidates are required to pay intimation charges/Application fees online from **5.2.2016 to 22.2.2016** (both dates inclusive) by following the instructions for online payment given under the link provided at www.mumbaiport.gov.in under 'Vacancy' menu.

Note1: Additional Bank transaction charge, for online payment of intimation charges/fees is to be borne by the candidate.

Note2: If any SC, ST category candidate applies for a post as UR, then he is not eligible for relaxation in fee.

Note3: Fee/ Intimation charges once paid will NOT be refunded on any account nor can it be held reserve for any other examination or selection.

VIII. Test Centre for Online Test:

Examination Centers:

- The examination will be conducted online in venues in Mumbai given in the respective admit cards.
- No request for change of post/centre/venue/date/session for Examination shall be entertained.
- Mumbai Port Trust or designated organization on behalf of MbPT, however, reserves the right to cancel any of the Examination Centres and/ or add some other Centres, at its discretion, depending upon the response, administrative feasibility, etc.
- Mumbai Port Trust or designated organization on behalf of MbPT also reserves the right to allot the candidate to any other centre.
- Candidate will appear for the examination at an Examination Centre at his/her own risks and expenses and Mumbai Port Trust will not be responsible for any injury or losses etc. of any nature.

IX. Dates of online examination: The dates of online examination will be intimated in due course.

X. Candidates will not be permitted to appear for the online examination without the following documents:

- (1) Valid Admit Card for the respective date and session of Examination
- (2) Photo-identity proof (as specified) in original bearing the same name as it appears on the Admit Card/ Application Form and
- (3) Photocopy of the above photo-identity proof (as detailed below*)

*IDENTITY VERIFICATION

In the examination hall as well as at the time of interview, the Admit Card along with the original and a photocopy of the candidate's currently valid photo identity bearing the same name as it appears on the Admit Card such as PAN Card/ Passport/ Driving Licence/ Voter's Card/ Bank Passbook with photograph/ Photo identity proof issued by a Gazetted Officer on official letterhead/ Photo identity proof issued by a People's Representative on official letterhead/ valid Identity Card issued by a recognized college/ university/ Aadhar card with a photograph/ Employee ID should be submitted to the invigilator and the original shall be produced for verification. The candidate's identity will be verified with respect to his/her details on the Admit Card, in the Attendance List and requisite documents submitted. If identity of the candidate is in doubt the candidate may not be allowed to appear for the Examination/interview.

Note 1: Ration card and E-Aadhar are <u>not</u> valid ID proofs for this process.

Note 2: In case of candidates who have changed their name, will be allowed only if they produce original Gazette Notification/their original marriage certificate/Affidavit in original.

Note 3: Candidates have to produce, in original the photo identity proof and submit photocopy of the photo identity proof along with Examination Admit Card as well as the Interview Call Letter while attending the examination/ interview respectively, without which they will not be allowed to take up the examination/ interview. Candidates must note that the name as appearing on the Admit Card (provided during the process of registration) should match the name as appearing on the photo identity proof. If there is any mismatch between the name indicated in the Admit Card and Photo Identity Proof the candidate will not be allowed to appear for the examination. To avoid any dispute, name recorded at the time of registration should be identical to authorized identity proof.

CANDIDATES REPORTING LATE i.e. after the reporting time specified on the Admit Card for Examination will not be permitted to take the examination. The reporting time mentioned on the Admit Card is prior to the start time of the test. Though the duration of the examination is 2 hours (120)

minutes), candidates may be required to be at the venue for about 4 hours including the time required for completion of various formalities such as verification and collection of various requisite documents, logging in, giving of instructions, etc. and including disruption beyond control.

XI. <u>Interview – (Applicable for Class I & II posts):</u>

Candidates who have been shortlisted in the online examination may subsequently be called for an interview. The address of the venue, time and date of interview will be informed to the concerned candidates in the call letter.

Please note that any request regarding change in date/venue/time etc. of interview will not be entertained. However, Mumbai Port Trust reserves the right to hold supplementary process on particular date/venue/time etc. at its discretion, under unforeseen circumstances, if any.

LIST OF DOCUMENTS TO BE PRODUCED AT THE TIME OF INTERVIEW (applicable for Class I & II posts):

The following documents in original and self-attested photocopies in support of the candidate's eligibility and identity are to be invariably submitted at the time of interview failing which the candidate may not be permitted to appear for the interview. Non submission of requisite documents by the candidate at the time of interview will debar his candidature from further participation in the recruitment process.

- (i) Interview Call Letter
- (ii) Valid system generated printout of the online application form registered for the online examination and e-receipt.
- (iii) Proof of Date of Birth (Birth Certificate issued by the Competent Municipal Authorities or SSLC/ Std. X Certificate with DOB)
- (iv) Photo Identity Proof as indicated in clause pertaining to *IDENTITY VERIFICATION of this advertisement
- (v) Mark-sheets & certificates of educational qualifications and other relevant eligibility criteria documents as indicated against concerned posts.
- (vi) Caste Certificate, along with caste validity certificate, issued by the competent authority in the prescribed format as stipulated by Government of India in the case of SC / ST / OBC category candidates. Prescribed formats are attached herewith.

In case of candidates belonging to OBC category, certificate should specifically contain a clause that the candidate does not belong to creamy layer section excluded from the benefits of reservation for Other Backward Classes in Civil posts & services under Government of India. OBC caste certificate containing the Non-creamy layer clause should be valid as on the date of interview, if called for/shortlisting (as applicable) [issued within one year prior to the date of interview, if called for/shortlisting (as applicable)]. Caste Name mentioned in certificate should tally letter by letter with Central Government list / notification.

Candidates belonging to OBC category but coming under creamy layer and/ or if their caste does not find place in the Central List are not entitled to OBC reservation. They should indicate their category as General in the online application form.

(vii) Special instructions for SC/ST/OBC:

- a) The Caste/Tribe/Community certificate issued by the following Authorities in the prescribed form for SCs/STs and for OBCs will only be accepted as proof in support of a candidate's claim as belonging to the SC/ST/OBC categories:

- (2) Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate.
- (3) Revenue Officer not below the rank of Tehsildar.
- (4) Sub-Divisional Officer of the area where the candidate and/or his family normally resides.

Note: Caste validity certificate in original, from the appropriate authorities of the state/union territory from which the caste certificate was issued along with self-attested Photostat copy is to be submitted at the time of interview.
