REQUISITE QUALIFICATION

- 1) <u>Foreman Civil (S0)</u>: Full time regular Diploma in Civil Engineering from a recognized University/ Institution approved by NCVT or SCTE&VT.
- <u>Mining Mate (T0)</u>: HSC with Mining Mate Certificate of Competency (Restricted to Open cast Metalliferrous Mines) and posses valid First Aid Certificate.

All qualifications must be from recognised Institutions affiliated to Central /State Government.

COMPENSATION PACKAGE

1) Foreman (Civil)-

Selected candidates will be placed in the pay scale of Rs. 14,600 - 3% - 36,500/- at S0 grade.

2) Mining Mate -

Selected candidates will be placed in the pay scale of Rs. 11,700-3%-27,500/- at T0 grade.

Besides basic pay, they will be entitled to Dearness Allowance (DA), perquisite under cafeteria approach, HRA, PRP, medical facility for self & dependants and superannuation benefits *i.e.* Contributory Provident Fund, Gratuity, etc. as per rules of the Company in force from time to time. Further, the Company offers one of the best compensation packages as far as Cost to Company (CTC) is concerned with opportunity of merit-oriented advancement in a professionally managed organization focused on growth. The CTC mentioned above may vary depending upon the place of posting and other terms and conditions of appointment.

SELECTION PROCESS & PLACEMENT

- Candidates will be short-listed for the written test & personal interview in the respective discipline, subject to fulfilling the criteria as specified. Based on the performance in the written test & personal interview, the organizational requirement, the vacancies in the respective discipline and reservation points as per the Presidential Directives, the candidates will be selected.
- However, the Management reserves the right to change the minimum eligibility standards/criteria and/or to restrict the number of candidates in the personal interview, if so required.
- 3) During the probation period and/or after absorption, selected candidates will be posted in the NALCO establishments anywhere in India & is transferable as per the organizational requirement. The selected candidates may be assigned jobs/ functions/ assignments related to their area as per the requirements of the Company including shift operation.
- 4) The selection process will be as per the R&P rules for Non-executives of the company & other applicable guidelines. The decisions will be taken at the discretion of NALCO management & will be final & binding on the candidate

MEDICAL FITNESS

 The candidates seeking employment in NALCO need to be medically fit as per NALCO's pre-employment medical standard. The selected candidates will have to undergo medical examination by the authorized medical officer of NALCO and his/her decision will be final and binding. No relaxation in health standards as indicated in the medical rules of the Company is allowed.

RESERVATIONS AND RELAXATIONS

- Reservations/relaxations for SC/ST/PWD (degree of disability 40% or above) candidates as per Government guidelines are applicable. In case of increase or decrease in the number of total posts, the number of reserved category posts will vary in accordance to the Govt. guidelines.
- 2) PWD candidates would be required to furnish valid disability certificate duly stamped and signed by a medical panel empowered for the purpose and should comprise of 3 medical practitioners of Govt. hospital or medical board attached to Special Employment Exchange for the handicapped. None of the vacancies of the post Mining Mate is open for PWD candidates.
- 3) Appointment to some of the vacancies will be offered to the PWD candidates after considering the nature of duties and responsibilities of the assignment, location, etc. and also considering that the disability is not likely to interfere with the performance and without possible deterioration of his/her health. However, the final appointment and placement would be based on candidate's medical fitness with respect to the job requirement of the identified posts.
- 4) Category of SC/ST/OBC/PWD once filled in the online application form will not be changed. The reserved category candidates are required to submit requisite certificate in the prescribed format of Government of India, issued by the Competent Authority, at the time of personal interview, if called for.
- 5) If the SC/ST/OBC/PWD certificate has been issued in a language other than English/Hindi, the candidates will be required to submit a self-certified translated copy of the same either in English or Hindi.
- 6) The OBC candidates who belong to "Creamy Layer" are not entitled for concession admissible to OBC category and such candidates have to indicate their category as Unreserved (UR). Further, OBC candidates will have to give a self undertaking, indicating that they do not belong to OBC (Creamy Layer) category also at the time of personal interview, if called for.
- 7) The upper age limit is relaxed by 3 years for OBC, 5 years for SC/ST, 10 years for PWD- Un-reserved (UR) and 13 years for PWD-OBC & 15 years for PWD-SC/ST candidates.
- 8) Relaxation of five years in age will be extended to the candidates who had ordinarily been domiciled in the State of Jammu & Kashmir from 01.01.1980 to 31.12.1989. Ex-Servicemen and children/family members of those who died in the riots of 1984 will get relaxation as per directives of Govt. of India.
- 9) In case of land affected persons whose lands have been acquired for Nalco project at DAMANJODI and possesses the relevant certificate issued by the land acquisition authorities of state government in the name of self or in the name of parents or grandparents and none of their family member are employed in Nalco against the land acquired may be considered provided he/she is meeting the qualification, experience and age criteria. The maximum age limit is 40 years for land affected person as on 01/01/2016. The land affected candidates are required to submit all supporting documents including land documents; legal heir certificate issued by Govt. authorities, declaration showing nominee particulars & relationship between the candidate and land oustee by the candidate in non judicial stamp paper of Rs.50/-as per the prescribed format provided below, failing which the candidature will not be considered.

On the other hand if the document submitted or the declaration made or information furnished by the candidate are found to be false or incorrect at any point of time or there has been suppression of any facts, their candidature will be terminated forthwith without any notice or assigning any reason thereof.

HOW TO APPLY

Candidates should click on the online application link, read the instructions carefully and fill-in the online application form giving accurate information. If the online application is not successfully completed, candidate is required to register again. Applications received through any other mode would not be accepted and summarily rejected.
- 2) No request with respect to change in any data entered by the candidate will be entertained once the online application is submitted successfully. While applying online, candidate needs to upload the scanned copy of their recent passport size colour photograph, signature and demand draft towards application fee, (if applicable). In case the candidate is called for personal interview after getting selected in the written test, he/she will be required to produce his/her original certificate and other relevant documents as mentioned in the on-line application form.

GENERAL INSTRUCTIONS

- 1) Only Indian Nationals are eligible to apply.
- 2) The candidate should ensure that he/she fulfills the eligibility criteria and other conditions as mentioned in this advertisement. Mere submission of application does not imply that the Company (NALCO) has been satisfied about the candidate's eligibility.
