2.	Upper Age Limit	65 years as on 15.11.2016 (as on date of walk in interview)												
3.	Minimum Qualification	MBBS for Medical Officers and PG Degree in the relevant discipline for Medical Specialists from MCI recognized institutes.												
4.	Duration of engagement	Engagement would be on contractual basis for 1 year from the date of joining. The same may be extendable by two terms on yearly basis subject to mutually agreeable terms and conditions. Each term will be a fresh contract and at the end of each yearly term, contract will be deemed to have expired. If consent is given for extension, the same shall be deemed as fresh contract without any continuity.												
5.	Working Hours/ Leave	<p>a) For Medical Officers -8 hours General Shift on all working days. One day off per week. If need arises, as per instructions of Competent Authority,one might have to attend shift duties/emergencies as well. Medical officers shall be allowed 10 days leave during the period of contract.</p> <p>b) For Medical Specialists - 8 hours General Shift, 12 days in a month, to be fixed as per the direction of Director I/c (M&HS). No leave is permissible.</p>												
6.	Honorarium	For Medical Officers will be Rs.40,000/-per month and for Medical Specialists @Rs.3500/- per day with a maximum of Rs.42,000/- per month.												
7.	Accommodation	No accommodation shall be provided.												
8.	Medical Facility	For self only at DSP Hospital during the period of engagement provided he/she is not availing the same in previous organization under any post-retirement scheme.												

9.	Selection Procedure	<p>i) Selection of the candidates for contractual engagement as Medical Officers / Medical Specialists will be done through a walk-in interview.</p> <p>ii) Interested & eligible candidates having the requisite qualification can walk in for selection interview at a scheduled date at DSP hospital. Doctors who have retired from any of the SAIL/ Govt./ PSEs hospital would be given preference.</p> <p>iii) Engagement as Medical Officers/Medical Specialists will start immediately after the selection of the candidate is completed and orders are issued for engagement as Medical Officers/ Medical Specialists.</p> <p>iv) Candidates responding to the advertisement for “Engagement of Contractual Doctors in DSP Hospital” in DSP Hospital will have to submit an undertaking (<u>Annexure-A</u>) to the above effect.</p>

GENERAL CONDITIONS:

1. Candidate must be an Indian national possessing requisite qualification from an MCI recognized institute recognized by State Govt./Central Govt.
2. Eligible & interested candidate may appear in the walk-in-interview on the date, time & venue as mentioned in the SCHEDULE below, with all relevant documents(original +1 set self-attested photocopies):
 - a. Filled in application format with 4 additional recent passport size colour photographs
 - b. Pass certificate & mark-sheets for educational qualification
 - c. Experience Certificate showing relevant post qualification experience from the employer. (In case of retired employees, service certificate issued by the parent organization should be given)
 - d. Proof of date of birth (Class X pass certificate of recognized board/council OR Birth Certificate issued by Registrar of Birth & Death)
 - e. Valid Registration Certificate issued by any State Medical Council.
 - f. Photo Identity Proof (EPIC,PAN, Aadhar Card,Driving License)
3. All certificates & documents in support of eligibility will be verified only during walk-in-interview and any candidate who fails to produce the same will not be allowed to appear at the interview. Therefore candidates are requested to ensure their eligibility before appearing in the walk-in-interview.
4. Candidates may send scanned copy of the duly filled in application form (Annexure-B) to dspintake@saildsp.co.in through email or in hard copy to AGM (P&A-M&HS), Room No. 7, Administrative Block, First Floor, DSP Main Hospital, Durgapur-713205 latest by 12.11.2016. The engagement is purely on “contractual basis” and is not to be construed as giving rise to any right of regular appointment in Durgapur Steel Plant in any manner whatsoever.
5. DSP reserves the sole authority to consider the cases as per its rules and decision of DSP in this regard shall be firm & binding.
6. DSP reserves the right to reject any application **OR** cancel the candidature **OR** the whole process of test/interview **OR** admit less than the no. of doctors indicated above, without assigning any reason thereof and no enquiry or correspondence will be entertained in this connection. The decision of the Interview Board constituted by DSP for this purpose shall be final and binding.
7. Candidature of an applicant is liable to be rejected at any stage of the selection process or after selection, if any information provided by the candidate is found to be false or is found not to be in conformity with requisite eligibility criteria mentioned in the advertisement.
