- 2. Performance of the selected candidates against Job No. 142 & 143 shall be assessed before the expiry of the contract and those found suitable will be offered a substantive post. Appointment of staff members on contract who are not found suitable for substantive post shall be terminated on completion of the contract period.
- 3. The applications received in response to advertisement will be scrutinized and only short-listed candidates will be called for selection process. Merely fulfilling the requirements laid down in the advertisement will not automatically entitle any candidate to be called for skill / trade test and written test.
- 4. The Institute reserves the right to: (a) not to fill any of the advertised positions (b) fill consequential vacancies arising at the time of selection from available candidates. The number of positions is thus open to change.
- 5. Candidates applying for the Job. No. 142 & 143 are required to make online payment of ₹50/- towards application fee. (No application fee for SC/ST/PwD, & Woman candidates).
- 6. Job. No. 143 is identified suitable for PwD (OL/OA) candidates with not less than 40%.
- 7. Candidates are advised to satisfy themselves before applying that they possess the minimum essential qualifications and experience (if any) laid down in the advertisement.
- 8. Institute reserves the right to conduct skill/proficiency test for shortlisting criteria. Final selection will be done on the basis of written test.
- 9. The prescribed essential qualifications/experience indicated are bare minimum and mere possessions of same will not entitle the applicants to be called for selection process.

- 10. The relaxation in age limit for SC/ST/OBC(NCL) candidates are applicable only if the post is reserved for particular category as per rules. Age relaxation for PwD and Ex-serviceman candidates are as per rules.

- 14. Certificate in support of experience should be in proper format i.e. it should be on the organizations letter head, bear the date of issue, specific period of work, name and designation of the issuing authority along with their signature.
- 15. Application without photograph, signature and necessary certificates in support of their application shall be summarily rejected.
- 16. Candidates seeking reservation benefits available for SC/ST/OBC(NCL)/PwD must be in possession of the certificates in the format prescribed by GoI in support of their claim at the time of application. Candidates seeking reservation for OBC (NCL) is required to attach a declaration, in addition to certificate in the prescribed format issued by the competent authority (format enclosed at Annexure I).
- 17. Persons employed in Government and Semi-Government organization or Educational Institution must upload a no-objection certificate from their current employer in support of their application.
- 18. Candidates desirous to apply for more than one post should apply for each post separately.
- 19. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the Institute reserves the right to modify/ withdraw/cancel any communication made to the candidates.
