1. Application should be submitted in the prescribed format (which can be downloaded from the website noted below) **only by Registered Post**.
2. Application sent in a postal cover should contain only one application. More than one application should not be sent in a postal envelope.
3. Name of the post for which the application submitted should be mentioned scrupulously on the envelope and further it should also be mentioned in the appropriate place of the application along with under which category the application submitted.
4. A recent passport size photograph of the candidate should be affixed on the right side margin of the application and it should be self attested by the applicant. Only self attested copies of certificates should be submitted along with application and original certificates need not be sent. Applications without necessary copy of certificates will be rejected. However, the applicants should submit all the original certificates at the time of Interview.
5. Incomplete applications and applications containing false information will be summarily rejected.
6. If any of the claim of the applicant as noted in the application is found to be false, the Candidature of the application will be rejected without any notice.
7. On claiming priority, copy of the certificate with regard to the priority should be enclosed with the application. Failure to adhere, the same will lead to the rejection of the application.
8. On claiming preference in Tamil Medium, copy of such documents should be enclosed with the application.
