#### Note:

- i) The relaxation in upper age limit to SC/ST/OBC candidates is allowed on cumulative basis with only one of the remaining categories for which age relaxation is permitted, as mentioned in Sr.No. 4 to 9.
- ii) The maximum age limit specified i.e. 26 years is applicable to Unreserved (General) Category candidates.

### Educational Qualification (as of 22.11.2016):-

- Minimum a pass in Xth Standard examination or its equivalent.
- The candidate should be able to read and write in local vernacular language. Knowledge of English will be given added weightage.

There is no ceiling on upper qualification for recruitment in Substaff Cadre.

**APPLICATION FEES**: Application Fees/ Intimation Charges Payable (Online payment) shall be as follows

## **Methods of Payment:**

- 1. **Online Payment (Credit Card, Debit Card & Net Banking)** Bank Transaction charges for Online Payment of application fees/ intimation charges will have to be borne by candidates.
- 2. Offline Payment (Bank of Baroda Challan) On completion of the application on the online portal, it generates a Pay-in-slip/Cash Voucher/ Challan for payment fee (Bank of Baroda Challan).
