Reservation shall be provided as per Government guidelines.

ELIGIBILITY CRITERIA:-

Age :-

Should have completed minimum 18 years of age but should not be more than 26 years of age, as on <u>16th Dec. 2016</u>. Relaxation shall be granted in the upper age limit as per Government guidelines admissible to SC/ST/OBC/PWD/Ex-servicemen candidates and as mentioned below.

Note: (i) The relaxation in upper age limit to SC/ST/OBC candidates is allowed on cumulative basis with only one of the remaining categories for which age relaxation is permitted.

(ii) The maximum age limit specified i.e. 26 years is applicable to General Category candidates.

EDUCATIONAL QUALIFICATION:

- a. The Candidate should be "A pass in Xth Standard examination or its equivalent",
- **b.** The candidate should be able to read and write in local vernacular language. Knowledge of English language will be given added weightage.

APPLICATION FEES:

Application Fees/ Intimation Charges Payable (Online / Offline payment) shall be as follows:-

- Rs. 100/- for SC/ST/PWD/EXSM candidates.
- Rs. 400/- for all others,

METHOD OF PAYMENT:-

1. On Line Payment (Credit Card, Debit Card and Net Banking).

2. Off Line Payment (Bank Of Baroda Challan)- On completion of the application on the online portal, it generates a pay-in –slip/Voucher/Challan for payment of fees(Bank of Baroda Challan). Only this pay-in slip should be used for depositing the fees to enable the fees to be properly credited to bank' account. Go to the nearest Branch of Bank of baroda with this pay-in-slip and deposit the required amount in the Branch using this auto generated pay-in-slip only.
