2. Medical Standards :

Engagement of selected candidates shall be subject to his/her being declared medically fit for the Company's service by Govt. Medical Officer/CMO.

3. Leave:

The selected candidates shall be entitled for 01 day leave per month on accrued basis. In case of absence beyond 01 day leave, payment will be made on proportionately.

4. Duration of Contract: The contract will be only for a period of (07) seven months.

5. Travelling Allowances:
